- InvestM is running Cashback & Free Gold Offer (the “Promotion”) and invites all new and existing Clients of InvestM to participate. By participating in this Promotion, you agree to be bound by these Terms and Conditions herein (hereinafter the “Terms”) as these are set out below.

2. Eligibility

- This offer is open to all customers who are 18 years of age or older.
- To be eligible for this offer, participants must open a live trading account.

3. Limitations

- Employees and their relatives at the company are not allowed to participate in this campaign.
- Each client is only allowed to open one unique account to participate in this program.

4. Terms and Conditions

- The Levels below are based on the Net Deposit(s) made within the Program period.
- Transfers of funds between accounts are not considered as deposits for the Net Deposit(s) calculation.

The program period starts on October 1st and ends at November 30th.

- Clients who join the cashback promotion shall be eligible to receive a rebate. Rebate shall be calculated based on clients' trading volume.
- Rebate shall be provided in the form of commission to the Client's Cashback Wallet automatically and will be available either for withdrawal or can be used for trading purposes.
- Rebates shall be credited to the client's wallet after the positions closed monthly.
- Rebate shall be calculated based on the client's volume traded on FX, Gold, and Silver. Indices are excluded from the calculation.
- Scalped trades shall be excluded from the rebate calculation.
- Maximum rebate a client may receive in a month is \$2,500.

5. Gold Allocation

- Each eligible client will have 0.001 lots of Gold added to their account upon successful registration.
- The value of each 0.001 Gold lot is approximately \$308.88, with a Contract Size of 100.
- Only clients who deposited 1,000 USD or more will be able to receive the 0.001 lots of Free Gold.
- The position added to the client's account cannot be closed by the client.
- The trading account will remain disabled until a deposit is made by the client.

- During the trading interval, clients can withdraw profits equal to 20 USD for every lot traded. Any remaining amount will be deducted at the end of the one week.
